The Tackling Economic Crime Awards (TEACs) has been running for 3 years and each year has seen a growth in the number of companies and individuals who participate.

December 2019 saw the first-ever presentation of the TECAs where 300 professionals from public, private and third sector organisations gathered at a London venue to celebrate the amazing achievements of those involved in desisting all areas on economic crime.
